- Sessions are held at St Joseph's Institution (SJI) or at a Presenting Couple's (PC's) Home as indicated above.
- SJI sessions are held on Sunday mornings with mass from 8.30am till 1.30pm.
- Home sessions are hosted by the PCs and can be on Saturday afternoons, Sunday mornings or Sunday afternoons. You are asked to indicate your preference, but we may not always be able to meet your first or second preference.
- The MPC certificate will only be given out for **full attendance** at all six sessions.
- For compliance with guidelines of the Personal Data Protection Act, your submission of this document indicates your consent to:
